The interested bidder has to submit their Bid Documents [EMD (Mentioned in Point No.4) and required documents (mentioned in Point No.4)] on/ before **17<sup>th</sup> August 2021** UPTO 05.00 PM by way of hardcopy to the Authorized Officer. During the Online Inter-se Bidding, Bidder can improve their Bid Amount as per the 'Bid Increase Amount' (mentioned above) or its multiple and in case bid is placed during the last 5 minutes of the closing time of the e-Auction, the closing time will automatically get extended for 5 minutes (each time till the closure of e-Auction process), otherwise, it'll automatically get closed.
